- 1) SHALL BE SUBJECT TO THE CONSTITUTION AND RULES OF THE CANADIAN EQUESTRIAN FEDERATION AND THE LOCAL RULES OF THE COMPETITION;
- 2) REPRESENT THAT EVERY HORSE, RIDER, DRIVER, AND HANDLER IS ELIGIBLE AS ENTERED;
- 3) AGREE TO BE BOUND BY THE CONSTITUTION AND RULES OF THE CEF AND OF THE COMPETITION;
- 4) AGREE THAT THEY PARTICIPATE VOLUNTARILY IN THE COMPETITION FULLY AWARE THAT HORSE SPORTS AND THE COMPETITION INVOLVE INHERENT DANGEROUS RISK OF SERIOUS INJURY, AND BY PARTICIPATION THEY EXPRESSLY ASSUME ANY AND ALL RISKS OF INJURY OR LOSS, AND THEY AGREE TO INDEMNIFY AND HOLD THE ANCASTER AGRICULTURAL SOCIETY, THE COMPETITION AND THEIR OFFICIALS, DIRECTORS, EMPLOYEES OR AGENTS HARMLESS FROM AND AGAINST ALL CLAIMS INCLUDING FOR ANY INJURY OR LOSS RESULTED, DIRECTLY OR INDIRECTLY, FROM NEGLIGENT ACTS OR OMISSIONS OF SAID OFFICIALS, DIRECTORS, EMPLOYEES OR AGENTS OF THE ANCASTER AGRICULTURAL SOCIETY, THE CEF OR THE COMPETITION.
